MARCH 2016 DNP, INC SURVEY RESULTS

The March 2016 Survey Results from the informal data collection reveal some interesting characteristics of readers like you.

- 21% of respondents work in an academic setting and do not have contact with patients or work in a patient care setting.
- 33% report working in an academic setting yet have regular contact with patients as a part of their faculty practice.
- 70% of respondents report that clinical practice influences their work in academia (and 30% report not at all or minimally).
- 77% report that their academic employer requires proficiency in the practice of nursing.

ORGANIZATIONAL UPDATE

In March we rolled out a new feature that encourages all University DNP Programs to enter and update information about their college or university. This is a positive step for all programs allowing for an easy change in information as needed, and takes out the middleman of the web designer in updating content. All schools are in the process of being contacted and invited to follow up so that the DNP Inc. organization can share your username and password. Information including accreditation can be selected and displayed easily. For more information contact us at info@doctorsofnursingpractice.org.

Phase 2 of this effort continues to be the development of the Doctoral Project Repository. Challenges in how the data will be displayed are being addressed. The process will involve an independent entry of information, then a blinded review with feedback, and if the submission meets the established criteria it will be displayed on the web site with a unique URL address that can be shared as desired. This will help to promote the archiving in a robust repository and assist in the dissemination of doctoral prepared work. We are looking forward to this becoming a reality soon.
