

# A De-escalation Protocol for Opioid Use Among Select Oncology Patients

According to the American Cancer Society and the National Cancer Institute, cancer survivorship begins the day an individual is diagnosed through the remainder of their life. It is projected that between 2016 and 2026, cancer survivors will grow to exceed 20 million in number (Miller, 2016). Oncology survivors represent a disregarded cohort with opioid misuse and addiction potential often compounded by narcotic pain relief necessitated by treatment. In my opinion, opioid de-escalation is an overlooked problem. In the spirit of *DNP Essentials III Clinical Scholarship and Analytical Methods for Evidence- Based Practice* my goal is to integrate current knowledge and narcotic practice guidelines into developing a narcotic de-escalation protocol for oncology patients who achieve cure or otherwise appropriate candidates.

Opioid misuse, addiction, and overdose related deaths capture national attention almost daily. Despite recent data indicating less prescriptions being written for acute pain, there is no indication opioid use is declining (Centers for Disease Control and Prevention, 2018). A recent literature search revealed a plethora of narcotic guidelines addressing acute or chronic non-malignant protocols. However, no guidelines were found for dose reducing in oncology patients. The ability to answer this

clinical question can be attributed to my progressing DNP education. My classes broadened my data mining skills and instilled skill sets required to analyze research data. These essential building blocks, as reflective in the DNP Essentials, providing a platform for my current and future clinical endeavors.

Transitioning from an MSN prepared nurse practitioner to a DNP prepared provider necessitates a "blinders off" visual perspective, thereby, preparing us to recognize all aspects that encompasses a health-related problem. For example, the exponential growth of opioid misuse and overdose deaths directs concern to the associated societal costs. Florence, Zhou, Luo, and Xu (2016), evaluated the economic burden of prescription opioid misuse by analyzing data from overdose deaths, lost wages, criminal related costs, and health care costs, including related substance abuse treatment costs. The authors determined the overall societal economic burden of opioid misuse at approximately \$78.5 billion for 2013. Of this \$78 billion, \$28.9 billion was allocated for substance abuse treatment. Yet a gap remains with limited if any information on my population of interest.

In summary, no single policy or singular effort targeting the opioid crisis will be enough. I believe most nurses most nurses innately discern healthcare related problems needing attention but often shy away from quality improvement or policy development. I attribute this to QI process knowledge deficit, lack of experience in evidence-based-practice, or simply fear of the unknown. By focusing on the DNP Essentials for leadership growth and partnering with diverse nursing work forces, national health epidemics such as opioid abuse and addiction may finally see a declining trend. My goal is to contribute to this effort by channeling my energies on evidence and best practice efforts for my cancer patients who may be appropriately weaned from opioids.
