

The Value of Dissemination for the DNP Graduate

Dissemination of scholarly thought and efforts reflects the foundation of professional nursing. Sharing knowledge, experiences, and findings of investigations supports the growth of the profession which improves practice and healthcare outcomes. This is a cyclical process that relies on the professional nurse to devote time and effort to enhancing practice and sharing findings. The cycle begins with a curiosity and identification of a need. As nursing professionals, we address this need and explore options and opportunities. This exploration leads to appreciating available knowledge of experimenting to generate new knowledge. Practice is improved when this knowledge is applied to nursing services. The product of this effort is improved practice process and improved client outcomes. Sharing this knowledge through mechanisms of dissemination is the final step to share and support the on-going growth and evolution of the profession.

When exploring dissemination opportunities, the first step is to identify stakeholders. Who has a vested interest in the information to be shared? We can anticipate that primary stakeholders are clients and their families. All of our efforts are directed at improving our clients' health. Secondary stakeholders may be nursing colleagues on a specific unit, nursing leadership, hospital administration, healthcare system management, or any other group that has a similar or overlapping investment in the goals of improving the health care outcomes of clients.

Consider the following options for dissemination:

Professional Organizations:

- Does the organization have a focus that reflects your work?
- *Are you a member of this organization?

Internet Dissemination:

- •Does a company's website have a similar goal and interest to your work?
- Are you familiar with the company as a customer, a member, or a contributor?

Conferences and Symposia:

- •Are guidelines and timelines for presentation available, and do they meet your schedule?
- Does the conference offer any remuneration or discount for presenters?

Continuing Education Offerings:

- *Does the Continuing Education Company accept unsolicited submissions?
 *Does the diversity of CE offering provided by this company fit with the intended submission?

Collaboration with Community Organizations:

- Does the mission of the organization fit with the findings of the information to be disseminated?
- *Is the scope of the community organization local, regional, national or international?

Peer-Reviewed Publications:

- Can you identify the publication that best reflect the direction of your work?
 Have you identified the directions and guidelines for manuscript submission?

Consumer-Driven Publications:

- •Does the publication address the needs of target population?
- •What is the typical length of articles in the publication?

Organizational Policies, Procedures, and Protocol:

- Do the key stakeholders involved in dissemination have influence over organizational policies?
- Who initiates the process of policy, procedure, or protocol change?

Legislative Initiatives:

- Do you perceive a need for legislative action locally, state-wide, nationally, or internationally?
- *Have you contacted the legislator to request support to share your knowledge and expertise? (O'Dell, 2015).

Dr. Michelle Taylor Skipper serves a Clinical Associate Professor and the Director of the DNP Program at East Carolina University, where she is responsible for the AGPCNP, FNP and Post-Masters specialty areas. She has been a family nurse practitioner for 23 years, providing primary care to women in rural southeastern North Carolina. In 2017, she was honored with the Governor's Award for Excellence for Public Service for her service to her home community during Hurricane Matthew and her decade-long mission service in Leon, Nicaragua. She has multiple publications and presentations on service learning and nursing education.

JUNE 2019 DNP, INC SURVEY RESULTS

The June 2019 Survey explored Essential VII addressing points of view on clinical prevention and population health to improve the nation's health. What are your thoughts on these findings? Do you agree with our peers?

Question 1: Essential VII addresses clinical prevention and population health for improving the nation's health. In your DNP program did you analyze epidemiological, biostatistical, and environmental data to appreciate ways to improve population health?

61% very much to absolutely, 39% somewhat to not at all

Question 2: After graduation, have you participated in an initiative that addressed aggregate or population health issues?

67% very much to absolutely, 33% somewhat to not at all

Question 3: After earning your DNP degree, have you applied concepts of psychosocial dimensions and cultural diversity to improve health status or address gaps in care? 78% very much to absolutely, 22% somewhat to not at all

Question 4: Since earning your DNP degree, have you had any involvement in developing, implementing, and/or evaluation interventions to address health promotion or disease prevention?

61% very much to absolutely, 39% somewhat to not at all

Question 5: As a DNP prepared professional have you applied care delivery strategies using concepts related to community, environmental, occupational health, and/or cultural and socioeconomic dimensions of health?

78% very much to absolutely, 22% somewhat to not at all
